SMSC CLUB POLICY ON TRIPS

1. Reservations accepted on a first-come, first served basis. Minimum of \$25 required within 7 days of sign-up and all payments must be made on schedule to hold the reservation.
2. Cancellations from any activity over 24 hours long with lodging and /or transportation will be subject to a non-refundable penalty of \$10.00 with 90 or more days notice, \$20 with more than 45 days notice, as an administrative fee, unless a replacement is found. Any non-refundable charge for airfares, condo, or trip arrangements will also be assessed.
3. All other payments will be refunded to cancellees only after the trip is over and only to the extent that the trip did not incur a loss.
4. Trips will go if there is snow; participants will vote if conditions are marginal, unless otherwise noted in contract with tour operator.
5. Skiing is a hazardous sport involving rigorous exercise and travel under conditions of some risk. Each trip participant is PERSONALLY and SOLEY RESPONSIBLE to ensure that they are physically able to ski under the prevailing conditions, that their equipment is in proper condition and that arrangement for transportation and lodging satisfies his/her standards of safety and health. No member or officer of the Southern Maryland Ski Club, Inc. (SMSC), accepts any responsibility for personal injury or property damage to or involving participants.
6. Non-club members will be charged \$10 extra per trip, which shall be used towards trip expenses at the discretion of the trip leader. Any excess in funds from the trip shall be placed in the club treasury.
7. Any person under the age of 18, not accompanied by an adult family member, must have a signed permission slip.
8. Trip leaders shall submit a complete financial report of the trip to the treasurer within 30 days following the end of the trip.
